## Prof. Ramesh Chandra Sachar

Prof. Ramesh Chandra Sacharpassed away on 04th March, 2023.

Ramesh Chandra Sachar received his PhD in the year 1957 from the University of Delhi. He worked as a Biochemist, Division of Biochemistry, India Agricultural Research Institute from the year 1968 to 1978 and joined the University of Delhi as a Professor in the Department of Botany in the year 1978. He was elected as a Fellow of National Academy of Science in the year 1989. He served the University till 1988 as Professor.

His contributions in the field of Physiology and Biochemistry have been outstanding and exemplary.

### Prof. Ashok Kumar Prasad

Prof. Ashok Kumar Prasad passed away on 08th February, 2023.

Prof. Ashok Kumar Prasad was the Head Department of Chemistry and the Dean, Faculty of Science of the University when he passed away at the age of 62 years. He did his PhD from University of Delhi in the year 1990 in the area of synthesis of Bioactive Polyphenolic Nature Products.

After spending about a decade has post-doctoral fellow / visiting Scientist at various prestigious institutions of the world, Dr. Prasad joined the Department of Chemistry as Reader in September, 2001 and subsequently became Professor in June, 2009. He was a member of various National and International Professional societies.

Prof. Ashok Kumar Prasad was an excellent teacher and outstanding researcher, who contributed enormously to the field of Bio-organic Chemistry.

### Prof. Avinash Kumar

Prof. Avinash Kumar passed away on 13th January 2023.

Prof. Avinash Kumar completed his Ph.D. in the year 2008. He has remained associated with the university since the year 2007 when he joined the University as an Assistant Professor with the Department of Psychology. He became Professor in the year 2015 and became the Head of the Department with effect from April, 2021 till his last day in Office.

His areas of specialization in Psychology include Industrial/Organizational Psychology, Community Psychology, Organizational Citizenship Behaviour. He has authored several books which include Introduction to Applied Psychology, Hand Book for Organizational behavior, Sports Psychology, Advanced Social Psychology, MCQs in Psychology. He has made significant and invaluable contribution towards furtherance of knowledge in Psychology.

### Prof. S.C. Tiwari

Prof. S.C. Tiwari passed away on 13th November, 2022.

Prof. S.C. Tiwari belonged to the second batch of M.Sc. Anthropology students after the creation of the Department of Anthropology at the University of Delhi in the year 1947. He was one of the founding Fathers of the Department and taught and guided generations of the students in the subject area of Anthropology. He was appointed as Lecturer in the Department of Anthropology in the year 1954 and he superannuated as Professor in the year 1993 after serving the Department as Head and also serving the Faculty of Science as its Dean with unmatched devotion and dedication.

He has made significant contribution in the subject area of Anthropology through his persistent research endeavours.

### Prof. A. N. Mitra

Prof. A. N. Mitrapassed away on 26th November, 2022.

Prof. A. N. Mitra joined the Department of Physics & Astrophysics as a Reader on 09<sup>th</sup> September, 1960. He was promoted as a Professor on 16<sup>th</sup> July, 1963. He served the Department as the Head from the year 1973 to 1975 for a period of two years. He superannuated on 31<sup>st</sup> October, 1994 from the University. Prof. Mitra was conferred as the "Professor Emeritus" of the University for his Outstanding contribution in teaching and research in Physics by the Executive Council in December, 2009. He served the University for more than 34 years.

### Prof. Kanwal Kishore Singh

Prof. Kanwal Kishore Singh passed away on 24th September, 2022.

Prof. Kanwal Kishore Singh joined the Department of Physics & Astrophysics of the University in the capacity of a Lecturer in the year 1955 and was promoted as a Reader in 1966 and Professor in the year 1983. He superannuated from the services of the University on 30<sup>th</sup> September 1991. He was re-employed as a Professor with effect from 1<sup>st</sup> October 1991 for a period of five years. He served the University for 41 years. He has made significant contribution in the subject area of Physics.

# (iii) COMPETENCE ENHANCEMENT SCHEME (CES)

The University has launched a new scheme called the Competence Enhancement Scheme (CES) in its centennial year to make higher education more accessible, as envisaged under the National Education Policy 2020. The Scheme shall provide opportunities to people from all walks of life to enhance their knowledge/competence by registering for any one or two courses offered in a semester in the Colleges and Departments of the University. Such candidate shall get the flavour of studying in the University along with the regular students of such course(s) without having to enroll for a Programme of study.

The number of seats per course prescribed is a maximum of 10% of the class size of such course and these seats are treated as supernumerary seats.

## (v) VICE-CHANCELLOR INTERNSHIP SCHEME

The University has started the 'Vice Chancellor Internship Scheme' (VQIS) from the academic year 2022-2023 with an aim to provide internship opportunities to its students in the University which will help them to

understand the working of different sectors of the University system in particular and official functioning in government set-ups in general.

In the first cycle of the Scheme, 3424 applications were received, from which 113 interns were selected (108 Interns UG Students and 5 Interns PG Students) and are now currently engaged 27 branches/sections of the University, thus providing the much needed exposure and experience to these students.

# (vi) VIDYA VISTAR SCHEME (V2S)

For sharing the existing resources available in the University/College with the academic institutions of remote areas through academic collaboration. So far 36 colleges have been associated under V2S Scheme located in Bomdila, Arunachal Pradesh, Deithor, Assam, Drass, Ladakh, Barmer, Rajasthan, Pithoragarh, Uttarakhand, Mayabunder, Andaman etc.

# (vii) SAMARTH: TRANSFORMING HIGHER EDUCATION THROUGH E-GOVERNANCE

"Samarth" project was initiated by the Ministry of Education in 2019 with an aim to enable the universities and Higher Education Institutions (HEIs) towards planning, management, delivery, and monitoring of services for students, staff, and other stakeholders through a digital framework. The Principal Investigator of the Samarth Project is Prof. Sanjeev Singh, Institute of Informatics and Communications, University of Delhi.

Samarth has expanded its footprint to 27 States and 4 UTs across the country. Since its inception in 2019, Samarth has evolved over the years and now caters to 90 Lakh Student Records with 30 Lakh Academic Bank of Credits (ABC) accounts, 30 thousand employee records, over 7 Lakh applications for recruitment processed, 52 thousand files logged and tracked, 50 thousand online leave applications filed and processed, 80 thousand salary bills processed, over 80 Lakh applications for admission processed, and over 7 Lakh admissions conducted online by participating institutions every year. Samarth provided an admission portal for the Common University Entrance Test (CUET) conducted by National Testing Agency (NTA) in 2022 where 90 universities participated.

# (viii) FINANCIAL SUPPORT SCHEME (FSS) FOR STUDENTS

The University has initiated a financial support scheme for such students through a fee waiver in the spirit of the Government's motto "Sabka Sath SabkaVikas". The fee waiver includes all components of fee paid by students except examination fee & hostel fee, to the tune of upto 100% for students with family income less than 4 lakhs and upto 50% for students with family income between 4 to 8 lakhs.

CUET

Conducted by NTA, DU offers 75 programmes in 65 Colleges with more than 200 combinations.
