Prof. Shyam Sunder Chibber, Department of Chemistry

Prof. Shyam Sunder Chibber passed away on 16th October, 2023.

Prof. Shyam Sunder Chibber, former Faculty of Department of Chemistry had been the member of the University Court. Prof. Chibber has been the Head of the Department of Chemistry for the year 1990-1993.

His contribution in the field of Chemistry have been outstanding and exemplary.

Prof. J.P.S Uberoi, Department of Sociology

Prof. J.P.S Uberoi passed away on 03rd January, 2024

Born on the 5th of September 1934, Prof. Jit Singh Uberoi did a Bachelor's degree in Engineering from London, and an M.A. Anthropology from Manchester. He completed his PhD in Anthropology from Australian National University with a dissertation based on field work among the Tajiks in the northern highlands of Afghanistan.

During his 31 years in the University, Prof. Uberoi served as Proctor from 1971-73, as Head of the Department from 1977-1979, and as Director of the Delhi School of Economics in 1991-92.

Prof Uberoi was a Horniman scholar and received the Hocart Prize from the Royal Anthropological Institute, London, the Pranavananda Saraswati teacher's award from the UGC, and a Lifetime achievement award from the Indian Sociological Society. He was among the first group of Fellows at the Indian Institute of Advanced Study, Shimla and an ICSSR National Fellow after retirement in 2002-04. He passed away in Delhi on 3rd January 2024 leaving behind a rich legacy of scholarship.

Prof. V.K. Verma, Department of Geology

Prof. V.K. Verma passed away on 15th October, 2023

Prof. V.K. Verma served the Department of Geology, University of Delhi for more than thirty years. During his tenure he was Head of the Department twice from the year 1973 to 1979 and from the year 1993 to 1994.

5.3 RANKING

I. International Rankings

- The University of Delhi ranked 407th in the QS World Universities Rankings 2024, improving tremendously compared to last year's ranking, which is ranked 521-530.
- The University of Delhi has been ranked 1st in India (out of 56 Institutions, including IITs) and 220th globally (out of 1,403 Institutions) in the Quacquarelli Symonds (QS) World University Rankings: Sustainability 2024, with an overall score of 73.4 out of 100.
- The University moved significantly from 381-400 rank last year to 220th rank globally this year.
- The University of Delhi is the only Indian Institution in the top 250 globally.
- In the QS Asia University Rankings 2024, the University of Delhi ranked 94th. The University ranked among the Top 11% in QS Asia University Rankings 2024.
- Of the nine indicators, the University of Delhi has been ranked among 100 institutions globally in three indicators: 16th in Environmental Education, 66th in Environmental Sustainability, and 93rd in Knowledge Exchange. The University has also performed significantly well in the Governance indicator, ranking 167th.
- The University of Delhi ranked 801-1000 in the Times Higher Education: World Universities Rankings 2024, improving tremendously compared to last year's ranking, which is ranked 1001-1200.

II. National Ranking

- The University of Delhi has improved its ranking in both the Universities Category and the Overall category in the NIRF Rankings 2023.
- In the Universities category, it has jumped from 13th position (score 58.66) to 11th position (score 61.45), and in the Overall category, from 23rd position (score 57.63) to 22nd position (score 60.24).
- The University has improved its performance in almost all the parameters, including teaching learning and resources (increase in score by 1.068), research and professional practice (increase in score by 0.447), graduation outcome (increase in score by 1.196), and outreach and inclusivity (increase in score by 0.51).

5.11 NEW INITIATIVE

I. Orphan Quota:

The University has taken a noble decision of admitting two children (one male and one female) in each programme of study, both at the Undergraduate and Postgraduate level who have been rendered Orphan. These two seats are supernumerary.

The expenditure incurred for admission and continuance of study of such students including hostel expenditure in the University or its Colleges shall be met from the University Welfare Fund or Colleges Students' Welfare Fund, as the case may be, for admissions in the University or in the Colleges, respectively.

II. Competence Enhancement Scheme

The University has launched a new scheme called the Competence Enhancement Scheme (CES) in its centennial year to make higher education more accessible, as envisaged under the National Education Policy 2020.

The Scheme shall provide opportunities to people from all walks of life to enhance their knowledge/competence by registering for any one or two courses offered in a semester in the Colleges and Departments of the University.

Such students shall get the flavour of studying in the University along with the regular students of such course(s) without having to enroll for a Programme of study.

The number of seats per course prescribed is a maximum of 10% of the class size of such course and these seats are treated as supernumerary seats.

Admission under CES 2023-24 has been conducted for two semesters; July to December 2023 and January to April 2024.

III. Vice Chancellor Internship Scheme (VCIS)

The University has started the Vice Chancellor Internship Scheme (VCIS) from the academic year 2022-2023 with an aim to provide internship opportunities to its UG and PG students in the University through the office of Dean Students' Welfare. In the, last academic session 2022-23, 113 & 100 students were selected for Part-time & Summer Internship, respectively.

IV. Poor Student Support Fund (Financial Support Scheme)

The objective behind setting up Financial Support Scheme (FSS) is to extend the rationale of equity, access, and quality for the benefit of students from financially weaker backgrounds.

A total of 1669 students were declared eligible for availing benefits under FSS in 2023-24. A total amount of 1,20,41,638/- is being disbursed for the same.

The Samarth E-Gov Suite developed by University of Delhi, is a purpose built platform for Universities and HEIs to deploy a digital framework of good governance.

Sashakt Beti Project aims at empowering the female orphan students and single parent girl students (with yearly income of less than Rs 4 Lakh) of the University of Delhi and its constituent colleges and departments by giving free branded new laptops. In the first Phase, it is proposed to raise Rs 5 Crores (1,000 x 50,000) for the same.

e-Drishti Project aims at empowering Visually Impaired students of University of Delhi and its constituent colleges and departments by giving free tablets along with a specially designed AI-driven application. In the first Phase, it is proposed to raise Rs 2.5 Crores (1,000 x 25,000) for the same.

BSES Discoms (BRPL & BYPL) of Reliance Power has approved giving 300 laptops and 300 e-tablets (Total cost being Rs 2.25 Crore).



5.14 UDHMODYA FOUNDATION

Udhmodya Foundation has incubated 5 companies out of the identified 24 start-ups from the Start-up Accelerator Programme (SAP held in 2023). Funds have been sanctioned to 3 of these start-ups, to be disbursed in tranches. Another 6 start-ups are in the pre-incubation stage. Udhmodya Foundation has launched a special call for Start-ups under the Social Sustainable Category on 01st Jan 2024 under the Viksit Bharat Scheme.

5.15 MoUs signed by the University

The University of Delhi recognizes the immense significance of establishing academic ties with international universities. Within the last year, the University has strengthened its position by signing 12 new MoUs with various international universities and HEIs. In total, the University has more than 80 active MoUs with around 35 countries around the globe (Among these, we have 07 MoUs with Germany, 08 MoUs with Japan, 12 MoUs with Russia, and 06 MoUs with South Korea).

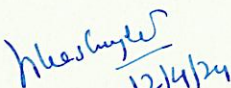
