The posts were created for running the courses with concurrence of Directorate of Higher Education, Govt. of NCT of Delhi.</p> <p>2.2 ensure timely release of funds (salary and other than salary) including deficit in respect of all the 12 Colleges for the smooth running and maintaining the Academic standards of the institutions.</p> <p>2.3 PWD be directed to ensure due repair(s) and timely maintenance of the buildings and other infrastructure in respect of these colleges in the larger interest of the students.</p>	<p>A letter dated 05.09.2024 has been issued by the University of Delhi to Hon'ble Minister of Education, Govt. of NCT of Delhi, New Delhi conveying the decision of the Joint meeting of the AC/EC.</p>
