## **Call for Applications and Nominations for the IPAI Chair on Public Finance and Audit at the Delhi School of Public Policy and Governance**

The Delhi School of Public Policy and Governance (DSPPG) has been set up by the University of Delhi under the Institutions of Eminence (IOE) scheme of the Government of India. DSPPG aims to bring together cutting-edge researchers, world-class scholars, public and private policy practitioners, and legal experts to deliver a unique set of research, teaching and training programmes.

The Institute of Public Auditors of India (IPAI) is a not-for-profit organisation set up in 1996 with the objective of: establishing sound accounting, auditing and other financial management practices in maintaining Public Funds; dissemination of the latest developments in the field of accounting, auditing and Financial Management. and rendering consultancy and advisory services to improve the systems related to public financial management. The Comptroller and Auditor General of India is the ex officio Patron of the IPAI.

In furtherance of their common objectives, the DSPPG and the IPAI have agreed to set up an IPAI Chair in the DSPPG in memory of the Late Shri Dharam Vir, the founding President of IPAI. The incumbent to the Chair would help further the following shared agenda of action by the IPAI and DSPPG:

- i) To develop courseware for certificate courses co-sponsored by IPAI & DSPPG in the area of public audit and cognate subjects
- ii) To conduct online / offline classes and project work for students enrolled in these certificate courses.
- iii) To conduct webinars on topics of interest relating to public audit, accountability and Finance, and
- iv) To conduct research in audits, accounts, public finance etc.

The implementation of the activities carried out by DSPPG in consultation with IPAI shall be reviewed and monitored at an appropriate level quarterly.

**Eligibility:** Applications from interested persons or nominations are invited for the Chair. Retired senior civil servants and academicians (of the rank of Professor and above) with specialisation in public finance, accounts and audit, preferably having experience working with the government, would be considered for appointment to the Chair. A search-cum-selection committee comprising nominees of IPAI and DSPPG will select a capable and interested person of eminence to hold the Chair. The decision of the selection committee will be final.

The incumbent to the IPAI Chair may pursue other activities so long as a conflict of interest is avoided with the functioning of the Chair. The tenure of the person so appointed shall be 2 years initially subject
