In view of the fact that names of applicant/s has/have to be compulsorily notified in the form of a short-list prepared for admission, the name/s of applicant/s, whose objection/s has/have been sustained by the Admission Committee, shall not be automatically included into the final list under preparation for admission."

You are also required to bring an <u>authentic certificate about your local guardian and a guarantor from some responsible persons</u>. <u>Students/researchers etc. will not be accepted as local guardians/guarantors</u>.
