The process for selecting the awardees from the applicants may be as follows:

1. Applications are to be invited from first and second-year students of M.Com. and MBA (HRD) course.
2. The application is to be accompanied by a brief write-up from the students about the reasons for applying for this scholarship and why it should be granted to them.
3. The main criterion for selecting the applicants will be the economic status of the students based on the parents' income certificate.
4. The applicants will undergo the process of an interview by a committee consisting of the Head of the Department and Programme Coordinators of M.Com. and MBA (HRD) to ensure that the scholarship goes in the right hands.
5. Since it is a need based scholarship, the applicants may be divided into the following categories such that category I may be given preference over category 2 and so on.

Category 1: Parents' annual income is less than ₹ 2,50,000

Category 2: Parents' annual income is between ₹ 2,50,000 to 4,00,000

Category 3: Parents' annual income is above ₹ 4,00,000

6. The annual income criteria is to be revised by the Department from time to time. Additionally, the interview committee may give preference to:

(i) Applicants whose parents have passed away.

(ii) Applicants who have studied in Government or Government-aided schools.



(b) The Council also noted that in the matter of Dr. Kiran Gupta the operation of judgement dated 08.03.2021 has been stayed by the Hon'ble Court till next date of hearing i.e. 03.10.2024.

Background: E.C. Resolution No. 7-10/- dated 01-02.07.2019 approving Promotion of following Faculty from Associate Professor (*Stage-IV*) to Professor (*Stage-V*) in the Faculty of Law w.e.f. 25.06.2019:

- a. Dr. Manju Arora Relan
- b. Dr. P.B. Pankaja
- c. Dr. Mahavir Singh Kalon
- d. Dr. Kiran Gupta

1. The Selection Committee for promotion of the above candidates was conducted on 25.06.2019 and as per recommendation of the selection committee they were promoted with effect from 25.06.2019 and not from the date of eligibility after due assessment. The recommendation of the selection committee were approved by the E.C. vide E.C. Resolution No. 7-10/- dated 01-02.07.2019. The respective faculty members filed a writ petitions in the Hon'ble High Court of Delhi as detailed below:

- WPC No. 10789/2019-Manju Arora Relan Vs UOD
- WPC No. 10744/2019- P.B. Pankaja Vs UOD,
- WPC No. 10564/2019-. Kiran Gupta Vs UOD
- WPC No. 1945/2022- Mahavir Singh Kalon Vs UOD

2. The matter was decided in the favour of the petitioners with respect to the case of WPC No. 10789/2019-Manju Arora Relan Vs UOD, WPC No. 10744/2019- P.B. Pankaja Vs UOD and WPC No. 10564/2019-. Kiran Gupta Vs UOD. Further, on the basis of this decision, the case of WPC No. 1945/2022- Mahavir Singh Kalon Vs UOD was also decided in the favour of the petitioner.

3. The Executive Council vide E.C. Resolution No. 70 dated: 18.03.2021 has considered the order passed by the Hon'ble High Court of Delhi in the Writ Petitions W.P.(C) 10564/2019, WP(C) 10744/2019 and WP(C) 10789/2019, CM No. 44576/2019 and authorized the Vice-Chancellor to take the decision.

4. That the LPAs as detailed below were filed on behalf of the University of Delhi:

- i. LPA (Appeal) No. 799/ 2023 titled University of Delhi Versus Dr. Mahavir Singh Kalon
- ii. LPA (Appeal) No. 822/ 2023 titled University of Delhi Versus Manju Arora Relan & Anr.
- iii. LPA (Appeal) No. 823/ 2023 titled University of Delhi Versus Prof. P.B. Pankaja & Ors.

The above noted LPAs were filed with a prayer to set aside the common judgment dated 08.03.2021 in matters of Prof. Manju Arora Relan & Prof. P.B. Pankaja, allowing the Writ Petitions filed by the said Faculty. The Judgment/ order dated 15.05.2023 in the matter of

E.C. (1270)-27.07.2024

Dr. Mahavir Singh Kalon, passed by the Ld. single judge, Hon'ble High Court, allowing the said Writ Petition was also challenged by way of LPA.

[On 08.03.2021 The Ld. Single Judge while disposing the Writ Petitions with observations and noted that the teachers named above are eligible for Promotion from *Stage-IV to Stage -V*, and said promotion will relate back to the date of eligibility and consequently the seniority would also reckon from the said date and not from the date of interview by the Selection Committee. The said position was observed in terms of the facts and Clause 6.3.12 of UGC Regulations 2010 (CAS-2010).]

5. The single judge order/ judgment was challenged by filing of the separate LPA's noted above. The LPA's have been dismissed vide common order/ judgment dated 01.05.2024 passed by the Division Bench after recording the stand/ statement of the counsel for the University Grants Commission (UGC), and it has been observed as following:

"4. Taking into account that the impugned orders are based on the UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in University and Colleges and Measurers for the Maintenance of Standard in Higher Education), Regulations 2010, ["UGC Regulations, 2010"] this Court had, on 15.12.2023, granted time to learned counsel for the UGC to obtain instructions regarding their stand qua the findings in the impugned order.

5. Mr. Apoorv Kurup, learned counsel for the UGC, submits that the impugned order correctly interprets the UGC Regulations, 2010. Consequently, the UGC has no grievance with the directions issued by the learned Single Judge.

6. Having perused the impugned orders and taking into account the stand taken by the learned counsel for UGC, we are of the considered view that all the respondents were, in terms of para 6.3.12 of the UGC Regulations 2010, entitled to promotion as Professor from the date of their eligibility. We, therefore, find no reason to interfere with the impugned order. The appeals being meritless are dismissed along with all accompanying applications."

6. Copy of the judgment dated 01.05.2024 passed by the Division Bench, Hon'ble High Court in LPA's is at **Appendix-79**.


