
**RECOMMENDATIONS OF THE COMMITTEE CONSTITUTED BY THE HON'BLE VICE-CHANCELLOR TO EXAMINE THE RULES WITH REGARD TO THE ANNUAL CONVOCATION AND ORDINANCE-XXVIII**

The Hon'ble Vice-Chancellor has constituted a committee consisting of the following to examine the rules with regard to the Annual Convocation and Ordinance-XXVIII (Medals & Prizes):

Meetings of the committee were held on 08-09-22, 21-09-22, 31-10-22 and 2-12-22. The committee decided as follows:


1. The committee suggested the following amendment with regard to the Order of Precedence mentioned in the Regulations of Convocation {Regulation-Convocation University Calendar Volume-II (page no.719 to 723)}. Accordingly, the amendment in the order of precedence is annexed as Annexure-I:
  - i. The Examination Wing plays a major role in organizing the convocation, therefore, the Dean (Examinations)/Controller of Examinations may be included in the Order of Precedence.
  - ii. The Deans and other equivalent officers who are appointed by the University from time to time to discharge various special functions, e.g. Dean (Academic Affairs), Dean (Research), Dean (International Relations) etc. may also be included in the Order of Precedence.
  - iii. The Registrar of the University would lead the convocation, and at the conclusion of the convocation, the order would be reversed. Apart from the Chief Guest/Guest of Honour, Chancellor, Pro-Chancellor, the following officials of the University shall be seated on the dias: Vice Chancellor, Pro Vice Chancellor, Dean of Colleges, Director of South Campus, Registrar and Dean Examination. Honourable Vice Chancellor may invite additional persons.
  - iv. Faculty of Agriculture and Forestry has been discontinued by the University of Delhi, therefore Dean of the Faculty of Agriculture and Forestry may be deleted from the Order of Precedence.
  - v. The precedence of persons falling under the same head in the table of precedence will be determined by the order in which their names are enrolled in the University Books.
  - vi. The first ex-officers of the University shall rank immediately below the present incumbents of those offices.



vii. The Vice-Chancellor shall determine from time to time as to the persons who will form the procession at the Convocation. Any dispute arising as to the seniority shall be decided by the Vice-Chancellor whose decision shall be final.

2. With regard to academic costumes, the committee invited Professor Jyoti Aggarwal and Dr. Bela Kapoor from Institute of Home Economics as Special Invitees. After detail deliberations, the committee suggested the amendment with regard to Academic Costumes at the time of convocation mentioned in the Regulations of Convocation {Regulation-Convocation University Calendar Volume-II (page no.719 to 723)}. Accordingly, the suggested amendment in the Academic Costumes at the time of convocation is annexed as Annexure-II
