- i. The Registrar of the University would lead the convocation, and at the conclusion of the convocation, the order would be reversed. Apart from the Chief Guest/Guest of Honour, Chancellor, Pro-Chancellor, the following officials of the University shall be seated on the dias: Vice Chancellor, Pro Vice Chancellor, Dean of Colleges, Director of South Campus, Registrar and Dean Examination. Honourable Vice Chancellor may invite additional persons.
- ii. The precedence of persons falling under the same head in the table of precedence will be determined by the order in which their names are enrolled in the University Books.
- iii. The first ex-officers of the University shall rank immediately below the present incumbents of those offices.
- iv. The Vice-Chancellor shall determine from time to time as to the persons who will form the procession at the Convocation. Any dispute arising as to the seniority shall be decided by the Vice-Chancellor whose decision shall be final.
