Subject: Guidelines for purposes of drawing a panel for making adhoc appointments of Lecturers in Colleges (approved by the Executive Council vide Resolution No. 120(8) dated 27.12.2007.

The above changes have been made in the light of the UGC (Minimum qualifications required for the appointment and career advancement of teachers in universities and institutions affiliated to it) 3rd Amendment, Regulation 2009, which has already been circulated to the Colleges and MHRD Order No. F.5-4/2005-U.I (A) dated 30th March, 2010, which is available on the website.

It may also be mentioned that in order to become eligible for appointment to the post of Lecturer/Assistant Professor on ad hoc basis, a candidate must possesses NET/SLET and or has been awarded Ph.D. Degree in compliance of the University Grants Commission (Minimum Standards And Procedure for Awards of Ph.D. Degree), 2009.

Any candidate, therefore, should not be appointed/re-appointed on ad hoc basis without possessing the above qualification w.e.f. 16/07/2010.
