**Subject: Recommendation for making minor modification in the pre-requisites of the B.A. Programme Discipline Specific Courses of Tamil and Telegu**

1. The issue of non-congruency between the **eligibility criteria** prescribed for pursuing BA (Program) with Tamil or Telugu (which indicates that no prior learning of Tamil or Telegu is required) as one of the core disciplines and the **pre-requisites** prescribed for studying the Discipline Specific Courses (DSC) of these two languages in the syllabi prescribed for BA (Program) (which states that the student should have studied Tamil/Telegu up to Class 10 or 8) comprising of these two language courses has been brought to the notice of the University.
2. To resolve the issue a meeting was held on Wednesday at 13.12.2022 at 12.30 P.M. in the office of Dean, Admission in which the following officials were present :
  - o Prof. K. Ratnabali, Dean, Academic Affairs
  - o Prof. Haneet Gandhi, Dean (Admissions)
  - o Prof. Amitava Chakraborty, Head, Department of Modern Indian Languages & Dean, Faculty of Arts
3. After due deliberations, the aforementioned officials unanimously recommended that in order to maintain the uniformity of the pre-requisites for all Languages offered in B.A. Programme and to align the same also with the eligibility criteria prescribed at the time of admission, the pre-requisites for the DSCs of Tamil and Telegu be modified and it should be read as 'NIL'. The minutes of the meeting is annexed as **Annexure-I**.
4. The above recommendation shall resolve the issue stated at point no. 1 above.
5. Accordingly, the recommendation is now placed for kind consideration and approval please.



1. A meeting was held on Wednesday at 13.12.2022 at 12.30 P.M. in the office of Dean, Admission for synchronization of pre-requisite for B.A. Programmes with Language(s) as core discipline(s).
2. Following officials were present in the meeting:
  - Prof. K. Ratnabali, Dean, Academic Affairs
  - Prof. Haneet Gandhi, Dean (Admissions)
  - Prof. Amitava Chakraborty, Head, Department of Modern Indian Languages & Dean, Faculty of Arts
3. The meeting was called to deliberate upon the issue of contradiction between the eligibility criteria prescribed for pursuing BA (Program) with Tamil or Telugu as one of the core disciplines and the pre-requisites prescribed for studying the Discipline Specific Courses (DSC) of these two languages in the syllabi prescribed for BA (Program) comprising of these courses.
4. On perusal of the pre-requisites prescribed for studying the DSCs of all languages for B.A. programme, it was noted that the pre-requisites are NIL for all these DSCs except Tamil and Telegu.
5. After due deliberations, the aforementioned officials unanimously recommended that in order to maintain the uniformity of the pre-requisites for all Languages offered in B.A. Programme and to align the same also with the eligibility criteria prescribed at the time of admission, the pre-requisites for the DSCs of Tamil and Telegu be modified and it should be read as 'NIL'.
