Item 1 Department of English

- The Committee, after due deliberations, approved the LOCF syllabus of the Department of English for B.A. (Hons.) English, B.A. (Hons.) Journalism (English), English for B.A./B.Com/B.Sc Programme and English for B.A (Hons.)/B.Com (Hons.)/B.Sc. (Hons.) for semester V. In this regard, the proposal of the Head, Department of English to replace the existing short story in the syllabus was accepted with inclusion of the story 'Sultana's Dream' by Begum Rokheya's. Further, the proposal of the Head, Department of English in this regard were taken note of in the course of deliberations and, the same was incorporated at serial No. (b) of Unit 2 under paper 11, Women's Writing of Semester V B.A. (Hons.)English.
- Further, minor amendments of serialization of the Discipline Specific Elective (DSE) Course for semester V were also noted and accordingly made by the Head, Department of English in line with the discussion in the meeting.
- The committee recommended that the syllabi for Semester V of the above syllabi may be uploaded by the Council Branch on the official website of the University after incorporation of the above amendments made available by the Department of English in both soft copy and hard copy.
