- 1. CONFIRMATION OF MINUTES OF THE FINANCE COMMITTEE MEETING HELD ON 17th SEPTEMBER, 2020
- 1.1 Minutes of the Finance Committee meeting held on 17th September, 2020 were circulated to all the members. After a brief discussion the minutes of the previous Finance Committee meeting held on 17th September, 2020 were confirmed.

2. ACTION TAKEN REPORT

- 2.1 Action Taken Report on Item No. 3.2 of minutes of previous meeting of the Finance Committee held on 17th September, 2020 was placed before the committee, which was noted.
- 3. TO CONSIDER THE UN-AUDITED ANNUAL ACCOUNTS OF THE UNIVERSITY, PROVIDENT FUND, NEW PENSION SCHEME, UNIVERSITY PRESS AND HALLS & HOSTELS FOR THE YEAR 2019-20
- 3.1 The Committee considered the un-audited Annual Accounts for the financial year 2019-20. The MoE vide letter F. No.9.2/2017-IFD.pt. dated 8.1.2021 has communicated that the presentation of annual accounts shall be as per revised format of accounts for CEIs. The Committee noted that the Annual Accounts have been prepared as per formats prescribed by the MoE, After due deliberations, the Committee recommended that the un-audited Annual Accounts of the University for the Financial Year 2019-20 be placed before the Executive Council for approval.
- 4. TO REPORT THE STATUS OF PENDING AUDIT PARAS OF THE UNIVERSITY
- 4.1 The status of Standing Audit Committee (SAC) meetings and audit parassettled/outstanding was placed before the Committee. The Committee recommended that all pending audit paras may be settled in time bound manner.
- 5. TO REPORT THE UTILIZATION OF FUNDS RECEIVED UNDER OH(35) CAPITAL ASSETS DURING LAST THREE YEARS AND UNDER OH (36) SALARY HEAD AND OH (31) RECURRING HEAD FOR THE PERIOD FROM 1.4.2020 TO 31.12.2020
- 5.1 Statement of Utilization of funds under Capital Assets for the period from 1.4.2017 till 31.12.2020 along with utilization of funds/grant received under Salary Head and Recurring Head for the period from 1.4.2020 to 31.12.2020was placed before the committee and noted.

Shri Fazal Mahmood raised the issue of un-utilized funds released to the University during the XII plan period, which need to be returned to the Government/UGC, as the funds could not be utilized for the purpose originally intended during the XII plan. He advised that the matter may be taken up with the UGC to settle the issue, forthwith.

- 10.1 The Committee discussed the matter in detail to consider the recommendations of the Committee (duly constituted by the Competent Authority) for revision of contractual fee/remunerations of the personnel engaged on contract basis in the University in view of Department of Personnel and Training (DoPT) Ministry of

Personnel, PG & Pensions Office Memorandum No. 49014/1/2017-Estt.(C) dated 4th September, 2019 on Equal Pay for Equal Work' for casual workers: compliance with instructions and Hon'ble Court Judgments thereon. After detailed deliberation, the Committee, in-principle, accepted the recommendations of the Committee for revision of contractual fee/remunerations of the personnel engaged on contract basis in the University w.e.f. 1st January, 2021. However, since the revised remuneration have financial implications for which additional funds would be required to meet the expenditure under OH:31; the University was advised to seek the prior approval of the UGC before implementing the recommendations of the Committee.
