The Action Taken Report on the decisions of the Finance Committee at its meeting held on 17<sup>th</sup> August, 2023 was noted.

However, the elected member Dr. J. L. Gupta on Item 1/03 of the ATR, again raised the issue related to the merger of staff working in the CEMDE into Deptt. of Environmental Studies. In response, it was assured that the matter shall be resolved by the duly constituted Committee.

Dr. J. L. Gupta on Item No. 8/10 has also suggested that remuneration payable to Teachers engaged at Central Evaluation Centers may also be reviewed. It was decided that a review be undertaken by a Committee to be constituted by the Vice-Chancellor.

# O5/ TO ADOPT THE SEPARATE AUDIT REPORT (SAR) ON THE ANNUAL ACCOUNTS OF THE UNIVERSITY FOR THE FINANCIAL YEAR 2022-23 ISSUED BY THE OFFICE OF THE DIRECTOR GENERAL OF AUDIT (CENTRAL EXPENDITURE)

The Treasurer presented the Separate Audit Report (SAR) on the Annual Accounts of the University for the Financial Year 2022-23 issued by the Office of the Director General of Audit (Central Expenditure), along with Audited Annual Accounts of the University for its adoption.

After deliberation, the Committee recommended the Audited Annual Accounts along with SAR for the Financial Year 2022-23 for placing before the Executive Council for its consideration and adoption.

## 06/ TO CONSIDER THE REVISED BUDGET ESTIMATES FOR THE FINANCIAL YEAR 2023-2024 AND BUDGET ESTIMATES FOR THE FINANCIAL YEAR 2024-2025.

The Treasurer presented the Revised Budget Estimates for 2023-24 and Budget Estimates for 2024-25 before the Committee and after deliberations, it was approved as follows:

### **REVISED BUDGET ESTIMATES – 2023-24**

The Committee noted that as against the Budget Estimates of Rs.1458.53 crores (Salary - Rs.876.34 crores and Recurring – Rs.582.19 crores) for the financial year 2023-24, the Revised Budget Estimates works out to Rs.1078.78 crores (Rs.509.61 crores under Salary (OH-36) which includes salaries, personal claims and retirement benefits etc. and Rs.569.17 crores under Recurring (OH-31) which includes Pension and Pensionary benefits, Non-Salary components and Non-NET Fellowships. The Committee also noted the Revised Estimates of Rs.67.88 crores under Capital Assets (OH-35).

### **BUDGET ESTIMATES – 2024-25**

The Committee also noted the Budget Estimates for the financial year 2024-25 which works out to Rs.1717.45 crores as follows:

Rs.935.26 crores under Salary (OH-36) head which includes salaries, personal claims and retirement benefits etc.

Rs. 627.31 crores under Recurring (OH-31) head which includes Pension and Pensionary benefits, Non-Salary components and Non-NET fellowships. Rs.154.88 crores under Capital Assets (OH-35).

Dr. J. L. Gupta appreciated the formation of the realistic and meticulous budget prepared under Revised Budget Estimates and Budget Estimates.

After due deliberation, the Committee recommended the Revised Budget for the financial year 2023-24 and Budget Estimates for the financial year 2024-25, for placing before the Executive Council for consideration and approval.

The Committee also decided to call a meeting of all the Maintained Institutions to discuss the matters related to the settlement of all the long outstanding para and also to take up the matter with the Office of the Comptroller General of Audit for review and settlement.

### 09/ TO REPORT THE STATUS OF PUBLIC GRIEVANCES AND STATUS OF PARLIAMENT ASSURANCES

The Committee noted the status of Public Grievances and Parliamentary Assurances. It was decided that efforts be put in to reply to the concern in a time-bound manner.

# 10/ TO REPORT THE LETTER NO. F.No.4-2/2022 CU-II DATED 13<sup>TH</sup> APRIL REG. CREATION OF TEACHING AND NON-TEACHING POSTS FOR FACULTY OF TECHNOLOGY, RECEIVED FROM MINISTRY OF EDUCATION, GOVT. OF INDIA

The Committee acknowledged the letter for creation of teaching and non-teaching posts for the Faculty of Technology and expressed its thanks letter to be issued to Ministry of Education, Ministry of Finance and UGC for their cooperation in sanctioning of posts.

## 11/ TO REPORT THE SANCTION OF FUNDS FOR EXECUTION OF 2 PROJECTS FOR FUNDING FROM HEFA.

- 2. Wi-Fi connectivity and expansion of the network at the University of Delhi vide HEFA sanction letter No. SAN/UOD/765/2023-24 dated 23.01.2024.

The Committee appreciated the efforts made by the MoE to approve funding through HEFA and expressed its thanks to the Secretary (IFD), Secretary (Expenditure), and Secretary, Higher Education of MoE.
