Vs University of Delhi & Ors., Delhi Metro Rail (O & M) Act 2002, Prevention of Damage to Public Property Act 1984, The Delhi University Acts & Statutes, The Delhi Prevention of Defacement of Property Act, 2007, Hon'ble National Green Tribunal Order in O.A. The filled up nomination paper duly verified by the Principal/Head of the Department/Institution should be deposited in the sealed box kept in the Office of the Chief Election Officer on working days between 10.00 a.m. to 5.00 p.m. but in no case later than 3.00 p.m. on Thursday, the 10<sup>th</sup> September, 2026 alongwith a Demand Draft of Rs. 500/- from any nationalized Bank in favour of the Treasurer, Delhi University Students' Union, Indemnity Bond by way of Affidavit on a Rs. 100/- Stamp Paper duly attested and notarized and Surety Bond (as per the Hon'ble Delhi High Court order in W.P. (C) 12832/2026 the surety bond can be furnished by any person including guardians, having the financial capacity to pay Rs. 1 Lakh and the same person shall stand as a surety for fulfillment of the said condition) on Rs. 100/- Non-Judicial Stamp Paper.
5. Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with copy of College/Department/Institution Identity Card. No withdrawal shall be allowed after 12.00 noon on Friday, the 11<sup>th</sup> September, 2026
