It is hereby notified for information of all concerned students who appeared in OBE examination held in March 2021 and desirous of applying for Revaluation/Rechecking/Photocopy of Evaluated Answer Scripts that they can apply for the above facilities through e-mail (except AECC and SEC Papers for which students may contact to their respective colleges/institutions).

The students are advised to follow the following procedure:

- 1. Application Forms for Revaluation/Rechecking/Photocopy of Evaluated Answer Scripts are available at http://exam.du.ac.in/Revaluation.html. The students are advised to go through the rules printed overleaf of the respective forms carefully before filling the form.
- 2. The students may take the print out of the Revaluation/Rechecking/Photocopy of Evaluated Answer Scripts forms.
- 3. The students are required to fill the form in his/her own handwriting and sign it. The requirement of counter signing the Form from the Dean/Head/Principal of the concerned Faculty/Department/College has been exempted for the OBE examination held in March 2021.
- 4. The students are required to enclose copy of Marks sheet and Admit Card of the OBE examination held in March 2021.
- 5. The students are required to pay the online fee of Revaluation/Rechecking/Photocopy of Evaluated answer script on the following link http://fee.du.ac.in/index.php/fee/fee-payment-miscellaneous/register
- 6. Finally, Students are required to scan the following documents i.e. Duly Filled and Signed Revaluation/Rechecking/Photocopy of Evaluated Answer Scripts form, Copy of Marks sheet, Copy of Admit card, Copy of fee Receipt in a single PDF File containing all the above documents and mail it to ar_revaluation@exam1.du.ac.in
- 7. The Under Graduate Students of Regular College which falls under the ambit of South Delhi Campus are required to send the documents to revaluation.south@exam1.du.ac.in
- 8. The last date to send the documents for all the courses whose results are already declared before the date of publication of this Notification is 20-07-2021.
- 9. The last date to apply for the above facilities for all the courses where results are declared after publication of this notification shall be as per the University Rules i.e. within 15 days of declaration of Result for Rechecking and Revaluation and within 61 to 75 day of declaration of Result for copy of Evaluated Answer Scripts. The Forms sent after the Due Dates specified as above shall not be accepted.

Note:-

- (i) Students are requested not to email the pdf of forms and documents more than once and wait for the acceptance of the form.
- (ii) Students are requested not to upload the PDF of answer scripts of applied papers.
- (iii) Rechecking is done instead of Revaluation for the examinations conducted by the University for All the Professional Courses such as LL.B.
