## "VIJENDRA SHARMILA CHOPRA MEMORIAL SCHOLARSHIP"

- There shall be a scholarship known as "Vijendra Sharmila Chopra Memorial Scholarship" of the value of <u>Rs. 100/- p.m.</u> tenable for 3 years to be awarded every year out of the annual income accurring from the endowment fund of <u>Rs. 24,000/-</u> (Rupees Twenty four thousand only) received from Shri R.N.Chopra, 38, Anand Niketan, New Delhi-110021.
- 2. The scholarship shall be awarded to a blind student who has passed the Senior Secondary Examination (Delhi/All India Senior Secondary Examination conducted by the Central Board of Secondary Education, New Delhi) obtaining the highest number of marks from amongst the applicants and joins the 1<sup>st</sup> year B.Sc., B.Com, B.A. Vocational Studies (Hons) or Pass Course in the University of Delhi.

3. In the first year the scholarship shall be awarded on the recommendation of a Selection Committee and the Scholarship will be renewable on yearly basis for the subsequent two years on the basis of satisfactory performance of the awardee.

4. No student shall be eligible for the above scholarship if he/she is in receipt of any other scholarship/Financial Assistance, other than freeship from any other University/State Government/Central Government/Private Body.

5. In case a scholar is already in receipt of the above scholarship accepts any other scholarship or financial assistance from any other source, the amount received from this fund will be refunded by him/her to the University from the date she/he accepts any other scholarship or financial assistance. The unutilized amount will be added to the corpus of the endowment fund.

6. If it appears to the University at any time that a scholar is unable to show satisfactory progress or has been found guilty of gross misconduct or has been irregular in attendance, he/she shall after due warning in writing be reported by the Principal of his/her college to the Academic Council which may withdraw the scholarship.

## **REGULATIONS**

- a. Applications for the award of the scholarship should reach the Registrar, giving detailed information on the prescribed form obtainable from the Registrar's Office, by the date mentioned in the Notification issued, each time in this respect by the Registrar.
- b. The Scholarship shall be awarded by the Academic Council on the recommendation of the Selection Committee constituted as follows:-
  - 1. The Dean, Faculty of Arts(Chairman)
  - 2. The Dean, Faculty of Science
  - 3. A nominee of the Donor
- c. The donor's nominee shall be his son Shri Ravindra Chopra unless a notice in writing is given by the Donor or a change to the Registrar, University of Delhi, by the donor.
- d. The Selection Committee shall meet soon after,31st August, each year and the award of the Scholarship shall be finalized by the end of September.
- e. The donor shall be intimated about the name and address of the candidate to whom the scholarship has been awarded together with his/her bio-date, after the award is finalized by 15<sup>th</sup> October of each year.
- f. The payment of the scholarship amount shall be made to the scholar through the Principal of the College from May each year on presentation of a bill and a certificate to the effect that during the period covered in the bill the scholar was not in receipt of any other scholarship/financial assistance from any other source.
