**DELHI UNIVERSITY WOMEN'S ASSOCIATION SCHOLARSHIP**

1. There shall be two scholarship called the "***The Delhi University Women's Association Scholarship***" each of the value of ` 100/-\*\* p.m. payable out of the interest on the funds endowed by ***the Delhi University Women's Association*** for award to needy and deserving daughters of Jawans who pass the Senior School Certificate Examination (Class – 12) of the C.B.S.E., New Delhi, or an examination recognized as equivalent there to and joins the 1<sup>st</sup> year of the three years degree course of this University and are in need of financial assistance in pursuing their studies.
2. Each scholarship shall be tenable for three years. The continuation of the scholarship shall be on year to year basis subject to the student passing the examination at the end of each year. If a student who has been awarded a scholarship fails at the examination at the end of any year of the course, the scholarship stands terminated. The scholarship thus vacated shall be awarded to any other student reading in the class to which the student who was awarded the scholarship originally could not be promoted, provided that the latter student had passed all her previous examinations in the course without break and fulfills the conditions of Part – I above.
3. The scholarship shall be awarded by the Academic Council of the University on the recommendations of the following Selection Committee:-
  1. Dean, Faculty of Arts
  2. Dean, Faculty of Science
  3. Dean, Faculty of Social Sciences
  4. Dean, Faculty of Mathematics
  5. A representative of the Delhi University Women's Association.
4. No student shall be eligible for this scholarship if she already holds a scholarship awarded by the Delhi or any other University or the Central Government or any state of India or a private body.
5. In case the scholar is awarded any other scholarship or gets financial aid from any other source the amount received by her from this scholarship shall be refunded to the University from the date she is awarded any other scholarship or gets financial aid.
6. If it should appear at any time that scholar has failed to make satisfactory progress or has been guilty of gross misconduct or laziness or has been irregular in attendance, she, after due warning in writing, be reported by the Principal of her college to the Academic Council, who may withdraw the scholarship.
7. The payment of the scholarship amount will be made to the scholar through the Principal of her college on presentation of a bill and a certificate to the effect that during the period covered under the bill the scholar was not in receipt of any other financial assistance from any other source and that the progress at studies was satisfactory.
8. In the event of there being no a eligible student for award of the scholarship, the interest accruing from the deposit shall be added to the corpus of the fund.
9. The name and the home address of the awarded shall be communicated to the Delhi University Women's Association.
